'OUR GIFT TO MUM' MOTHER'S DAY GIFT WITH PURCHASE 2025 TERMS & CONDITIONS

- 1. These official rules ("Rules") apply to the "Our Gift for Mum" Mother's Day Gift with Purchase ("Promotion") conducted by Trondage United Pty Ltd (ACN 163 695 065) as trustee for Lin Family Trust No 2 of c/- Retail First Pty Ltd, Cnr Creek & Wynnum Roads, Cannon Hill, Queensland 4170 ("Promoter") for Cannon Hill Kmart Plaza ("Centre").
- 2. Information on how to redeem the giveaway forms part of these Rules. The Promoter may, at any time, amend, add to or delete any of these Rules.
- 3. The Promotion runs daily from 10.00am to 3.00pm Wednesday 7 May until Saturday 10 May 2025, while stock lasts ("Promotion Period").
- 4. To be eligible to claim a Prize a customer must make an "Eligible Purchase".

Eligible Purchase

- 5. An "Eligible Purchase" is a purchase of any goods or services purchased from a "Participating Retailer" at Cannon Hill Kmart Plaza; valued \$60 or more, in one or two transactions during the "Promotion Period", excluding Coles and Kmart.
- 6. "Eligible Purchase" must be evidenced by a "Valid Receipt" being an original official store receipt from a Participating Retailer that is clearly marked with the date of purchase, the amount of the purchase and the store trading name, and the Valid Receipt must be presented to collect Prize.
- 7. An "Eligible Purchase" does not include:
 - (i) gift vouchers; or
 - (ii) payments for rates, gas, electricity, telephone accounts, vehicle registration, subscriptions to health fund and/or ambulance subscription; (iii) deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or
 - (iv) telephone, internet or mobile phone calling cards or credit vouchers;
 - (v) cigarettes, vapes and tobacco products;
 - (vi) lottery or gaming products;
 - (vii) alcohol products;
 - (viii) lay-by payments deposits or finalisation of lay-by;
 - (iiv) purchases from Coles or Kmart.
- 8. A "Gift Card" is a card that is exchangeable for goods and services from a Participating Retailer.
- 9. A "Tobacco Product" includes:
- (a) tobacco (in any form); or
- (b) any product (for example a cigar or cigarette):
- (i) that contains tobacco as its main or a substantial ingredient; and
- (ii) that is designed or intended for human consumption or use; and
- (iii) that is not included in the Australian Register of Therapeutic Goods maintained under the Therapeutic Goods Act 1989 (Cth); or (c) a cigarette paper, cigarette roller or pipe.
- 10. A "Gaming Product" includes:
- (a) a lottery ticket under the Lotteries Act 1997 (Qld);
- (b) a ticket in a game of lucky envelopes or a promotional game that is scratched to reveal numbers, letters or symbols that may entitle the player of that game to a prize; or
- (c) a voucher or other acknowledgement for playing:
- (i) a game under the Casino Control Act 1982 (Qld);
- (ii) a gaming machine under the Gaming Machine Act 1991 (Qld); or
- (iii) an approved keno game under the Keno Act 1996 (Qld); (d) a ticket or other acknowledgement for a bet under the Wagering Act 1998 (Qld).
- 11. A "Alcohol Product" includes:
- (a) alcohol (in any form); or
- (b) any product (for example beer, wine, spirits, or pre-mixed drinks): (c) that contains alcohol as its main or a substantial ingredient; and (d) that is designed or intended for human consumption or use; and
- 12. Two (2) Valid Receipts can be presented to staff at the collection booth and must show a minimum spend amount of \$60 ("Minimum Spend" for 1 x Prouds Earrings and Necklace set). Valid receipt(s) can only be used once and dated the same day as collection between the "Promotion Period" or while stocks last. Valid Receipt(s) will be marked upon presentation, and that receipt(s) cannot be used again.

13. One prize per customer, each day applies, regardless of the total amount of receipts presented. Quantity of 100 available each day.

Participating Retailer

- 14. A "Participating Retailer" refers to all Specialty Retailers at Cannon Hill Kmart Plaza. This Promotion does not include purchases from Coles or Kmart.
- 15. The Promoter, Participating Retailers and their respective officeholder, employees, agents, contractors, and their immediate Family Members are not eligible to enter the Promotion. "Immediate Family Member" means any spouse, child, de-facto, or any other family member residing at the same premises as that person.

Prize

16. The total prize pool during the promotions includes 400qty Prouds Earrings and Necklace Jewellery set (100 sets each day) valued at \$74.90 each ("Prize"). Total Prize Value \$29,960. All amounts are inclusive of GST.

General

- 17. The Prize is not transferable for cash or exchangeable for any other goods or services and cannot be taken for cash.
- 18. Customers claiming a prize ("Claimant") will be required to supply personal details including name, suburb, phone number or email, and postcode.

All Claimants consent to their personal information being entered onto a database, which may be made available to the Promoter for marketing purposes including electronic newsletters relating to the promotion of the Centre and retailers located in the Centre. Claimants can choose to not subscribe and opt out at any time.
- 25. Claimants agree to have their name and photograph used for advertising purposes and/or to take part in promotional activities including, without limitation, being interviewed by television, radio and/or other mediums for public broadcast.
